OFFICE MEMORANDUM

The issue pertaining to association of Zonal Coordinators/Representatives of ICAR in the Selection Committees of various KVKs for selection to different posts in KVKs was under consideration of Council for some time past. After detailed examination of the issue, following decisions have been taken in supersession of all earlier instructions/guidelines/orders in the matter.

2. In the Selection Committees making selection to various posts in KVKs under following categories of Organization, neither the Zonal Coordinator of the concerned Zone nor the representative of ICAR shall be associated :

- a. ICAR Institutes including the Deemed Universities under it
- b. Central Agricultural University
- c. State Agricultural University
- d. Central University
- e. Central Government
- f. State Government
- g. Central/State Public Sector Undertakings
- h. Government Colleges
- i. Deemed Universities other than Deemed Universities under ICAR

3. The constitution of the selection committee in case of posts other than the post of Training Organizers in NGOs/Private Organizations including Private Colleges and all other organizations not listed in para 2 above shall be revised as under :

- 1. Head of the Organization under which
- KVK is sanctioned
 Chairperson

 2. Concerned Zonal Coordinator
 Member

 3. Representative of ICAR
 Member

 (To be nominated by the Director of nearby ICAR Institute Should be of Group "A" level (Re 2000, 12 con)

Should be of Group "A" level (Rs.8000-13,500) and also at least one level above the level in which the recruitment is to be made).

4. An expert in the relevant field

4. In case of selection to the post of Training Organizer in NGOs/Private Organizations including Private Colleges and all other organizations not listed in para 2 above shall be revised as under:

5. The meeting of the Selection Committee, as referred to at para 3 and para 4 above, can be held only if all the members of the Selection Committee besides the Chairman are present in the, meeting of Selection Committee in replacement of the guidelines of quorum as circulated earlier.

6. The decisions as indicated at para 2 to para 5 above come into force with immediate effect and the same shall be followed scrupulously without any deviation.
