While submitting the application of willing candidates, he/she is bound to abide the ICAR guidelines/instructions vide F.NO.33-8/2016-Estt.I Dated 19th September, 2016, F.No.Admn.7-1/2020-R&P and Dated 10th December, 2021 and F.No.Admn.7-1/2020-R&P, Datd 23.08.2024 that the part of the service rendered by the transferred employee prior to his transfer after availing the last promotion in the parent Institute shall not be counted for the purpose of his/her promotion to the next higher grade in the new Institute/Headquarters, for availing promotion including by Limited Departmental Competitive Examination(LDCE) to the next higher grade he/she has to render the prescribed years of service, as per the Recruitment Rules, in the New Institute/Headquarters.
