

- 3. The candidate should submit the application in the prescribed proforma before 10.30 am on the day of interview along with attested copies of documents.
- 4. The candidate shall have to produce the **original documents at the time of interview & joining**, in case of selection, failing which, the candidature shall be cancelled and no right on the contractual appointment can be claimed for this advertisement.
- 5. The post is purely temporary and will be filled on contractual basis initially up to 31st March 2026 or till the completion/termination of the project, whichever earlier.
- 6. The contract may be extended periodically subject to satisfactory performance till the termination of the project.
- 7. Candidate shall have no right to claim regular appointment at the Institute, as the post is purely contractual and is co-terminus with the project.
- 8. Candidate having essential qualifications and submitting duly filled-in proforma along with selfattested copies of certificates and producing the Originals of the Certificates only would be allowed to appear in the Walk in Interview.

- 10. The candidate intending to appear in the Walk-in-interview, if any of his/her near or distant relatives are an employee of the ICAR/ATARI, have to declare his/her name, designation, nature of duties, relationship, in advance, before the start of interview to the undersigned.
- 11. The selected candidates will have to submit a medical fitness certificate and character certificate at the time of joining.
- 12. The vacancy is tentative. The Director, ICAR-ATARI Hyderabad reserves the right to withdraw the vacancy.
- 13. For leaving the contract in between the stipulated period, he/she shall have to give a minimum of one month notice in advance, to avoid the project work disturbed, failing which he/she will have to deposit one month salary with the employer.
- 14. His/her headquarter will be at ICAR-ATARI, Zone-X, Hyderabad and he/she will work under the immediate administrative control of the CCPI/Project In-charge of the said project and under the overall control of the Director, ICAR-ATARI, Zone-X, Hyderabad. However, he/she may be asked to go on tours anywhere in India to compile/collect data required for the project.
- 15. The ICAR will not be liable to bear any expenditure on pension contribution/leave salary contribution/Provident Fund, ESI, medical, insurance, etc.
- 16. Grant of leave, travelling and other allowances is regulated by Indian Council of Agricultural Research (ICAR), New Delhi mutatis mutandis, in accordance with the Project In-charge and supplementary rules and such other rules and orders as issued by the ICAR, New Delhi/Funding Agency from time to time.
